This Privacy Policy for Personal Data (hereinafter referred to as the “Privacy Policy”) applies to all information about the Website User on the Internet at www.languagelink.ru (hereinafter referred to as the “Website”) that can be obtained while using the website, its programs and products.

This Privacy Policy applies only to the Site www.languagelink.ru. The site www.languagelink.ru does not control and is not responsible for third-party sites, to which the User can follow the links available on the Site www.languagelink.ru.

The site administration does not verify the accuracy of the personal data provided by the Site User.

1. The personal information of the User permitted to be processed under this Privacy Policy are:

- Information about the User, which he provides about himself when registering (creating an account). Required to provide the Services information is marked in a special way. Other information is provided by the User at its discretion.

2. Purposes of processing User Personal Information:

- Identification of a User registered on the Site for registration at the Cambridge Exams.
- Receipt of information for the offer to the User of educational services. • Providing the User with access to personalized resources of the Site.
- Establishing feedback with the User, including sending notifications, inquiries regarding the use of the Site, the provision of services, processing requests and requests from the User.
- Processing and receiving payments, confirming tax or tax benefits, challenging the payment.
- Determine the location of the User to ensure security, prevent fraud.
- Confirmation of the accuracy and completeness of personal data provided by the User.
- Creating an account for the User, if the User has agreed to create an account.
- Notifications of the Site User about publications on the site.
- Providing the User with effective customer and technical support in case of problems related to the use of the Site.
- Implementation of promotional activities with the consent of the User.

The data are obtained for the purpose of concluding contracts within the framework of the statutory activity of the personal data operator and are not transferable to third parties without the consent of the subject of personal data.

The Site Administration guarantees that it will use the information obtained solely for the purposes specified in this Privacy Policy.

The site collects and stores only that personal information that is necessary for the provision of services or the execution of contracts with the User.

3. Conditions for processing User Personal Information

The site takes the necessary organizational and technical measures to protect the User's personal information from unlawful or accidental access, destruction, alteration, blocking, copying, distribution, as well as from other illegal actions by third parties.

The site stores the personal information of Users in accordance with the internal regulations of specific services.

The Site has the right to transfer the User's personal information to third parties only in the following cases: if the User gives his consent to the transfer or if such transfer is prescribed by applicable law.

The processing of the User's personal data is carried out without any time limit by any legal means, including in the personal data information systems using automation tools or without using such tools. The processing of users' personal data is carried out in accordance with Federal Law No. 152-FZ of July 27, 2006 "On Personal Data".

In case of loss or disclosure of personal data, the Site Administration informs the User about the loss or disclosure of personal data.

The site undertakes to block and destroy the User's personal data from the moment the User's corresponding request or prescription of the authorized body to protect the rights of personal data subjects.

4. Consent of the User to the processing of personal data

The use of the Site's services means the unconditional acceptance of the User with this Policy and the conditions for processing his personal information specified therein; in case of disagreement with these conditions, the User must refrain from using the services.

Using the services of the Site, the User confirms that he acts on his own will and in his interest, and also expresses his consent to the following actions with the provided personal data: collection, systematization, accumulation, storage, refinement (update or change), use, depersonalization, blocking, destruction, as well as the implementation of any other actions with personal data in accordance with applicable law. Data processing can be carried out with the use of automation tools, and without using them (with non-automatic processing).

When transferring data in order to participate in the Cambridge exams, the User confirms that, if necessary, the Company has the right to provide the User's personal data to third parties, including making a cross-border transfer, solely for the purpose of rendering agreed services and contractual

obligations and in compliance with the provisions of the Federal Law of July 27, 2006 No. 152-Φ3 “On Personal Data”.

5. Responsibility, dispute resolution

The site is responsible for violation of the rules for working with personal data provided for by the Federal Law of 27.07.2006 N 152-Φ3 “On Personal Data”.

In case of loss or disclosure of confidential information, the Site Administration is not liable if this confidential information:

- Became public domain before its loss or disclosure.
- It was received from a third party prior to its receipt by the Site Administration.
- Has been disclosed with the consent of the User.

Prior to filing a lawsuit in disputes arising from the relationship between the Site User and the Site Administration, it is mandatory to file a claim (a written proposal for a voluntary settlement of the dispute). The claimant must notify the claimant in writing about the results of the consideration of the claim within 20 calendar days from the date of its receipt.

If an agreement is not reached, the dispute will be submitted to the court in accordance with the current legislation of the Russian Federation.

6. Additional Terms

The Site Administration has the right to make changes to this Privacy Policy without the consent of the User.

A new Privacy Policy takes effect from the moment it is posted on the Website, unless otherwise provided by the new edition of the Privacy Policy.
